# WHAT DOES T Bank N.A. DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect, and share depend on the product or service you have with us. This information can include:

- Social Security number and checking account information
- Account balances and wire transfer instructions
- Transaction history and Retirement assets

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons T Bank NA chooses to share; and whether you can limit this sharing.

How does T Bank NA protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does T Bank NA collect my personal information?	We collect your personal information, for example, when you

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	■ T Bank NA shares information with Cain, Watters & Associates, LLC only if you currently maintain a relationship with them. T Bank NA shares information with Tectonic Advisors, LLC, who provides various services necessary to administer accounts.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	■ T Bank NA does not share with non-affiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

#### Other important information

#### **Special Notice for State Residents**

For California Customers. We will not share personal information with non-affiliates either for them to market to you or for join marketing – without your authorization. We will also limit our sharing for personal information about you with our affiliates to comply with all California privacy laws that apply to us.

T Bank NA does not jointly market.

For Vermont Customers. We will not share personal information with non-affiliates for them to market to you without your authorization and we will not share personal information with affiliates for joint marketing about your creditworthiness without your authorization.

For Nevada Customers. We will not share personal information with non-affiliates for them to market to you without your authorization and we will not share personal information with affiliates for joint marketing about your creditworthiness without your authorization.
